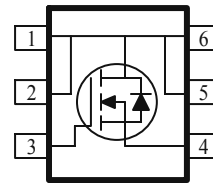
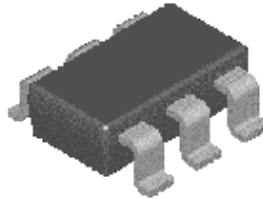


**N-Channel 30V (D-S) MOSFET**
