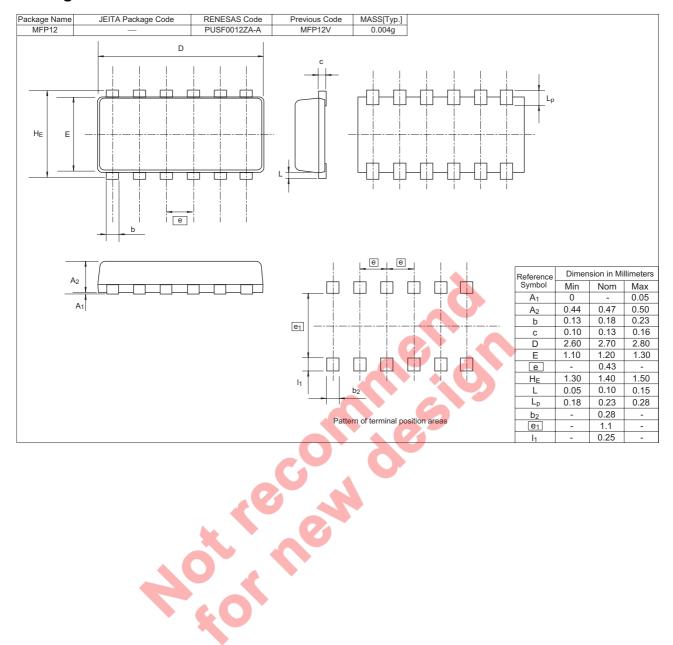
### **Main Characteristic (RKP200KP Series)**
