






Fig. 6.1 Marking




Fig. 7.1 Ic - VCE





Fig. 7.3 V<sub>CE(sat)</sub> - I<sub>C</sub>






Fig. 7.2 hFE - IC




Fig. 7.4 V<sub>BE(sat)</sub> - I<sub>C</sub>




Fig. 7.6 f<sub>T</sub> - I<sub>C</sub>




Fig. 7.7 r<sub>th</sub> - t<sub>w</sub> (Guaranteed Maximum)





Fig. 7.8 Safe Operating Area (Guaranteed Maximum)
