




Threshold Voltage Variance vs. Temperature

I_{GSS} vs. Temperature





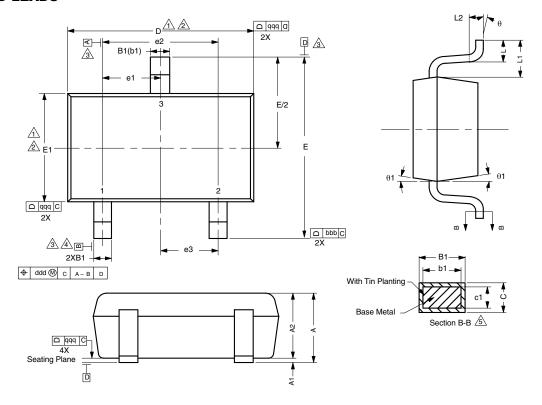

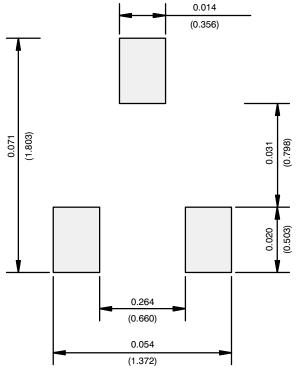
