


Figure 1. Transient Thermal Impedance




Figure 2. Saturation Characteristics




Figure 3. Transfer Characteristics




Figure 4. Gate Charge




Figure 5. Capacitance




Figure 6. Threshold Voltage vs. Temperature




Figure 7. On Resistance vs. Gate Voltage




Figure 8. Normalized On Resistance vs. Temperature




Figure 9. Typical Diode Forward Voltage




Figure 10. Maximum Safe Operating Area




Figure 11. Single Pulse Unclamped Inductive Switching





Figure 12. Maximum Drain Current vs. Temperature






Recommended PCB Pattern


