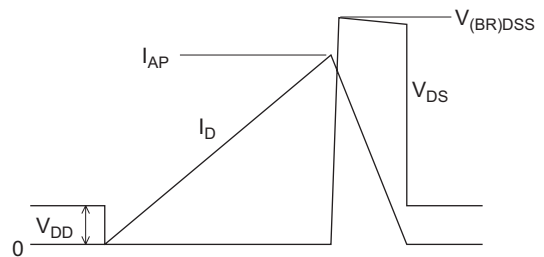


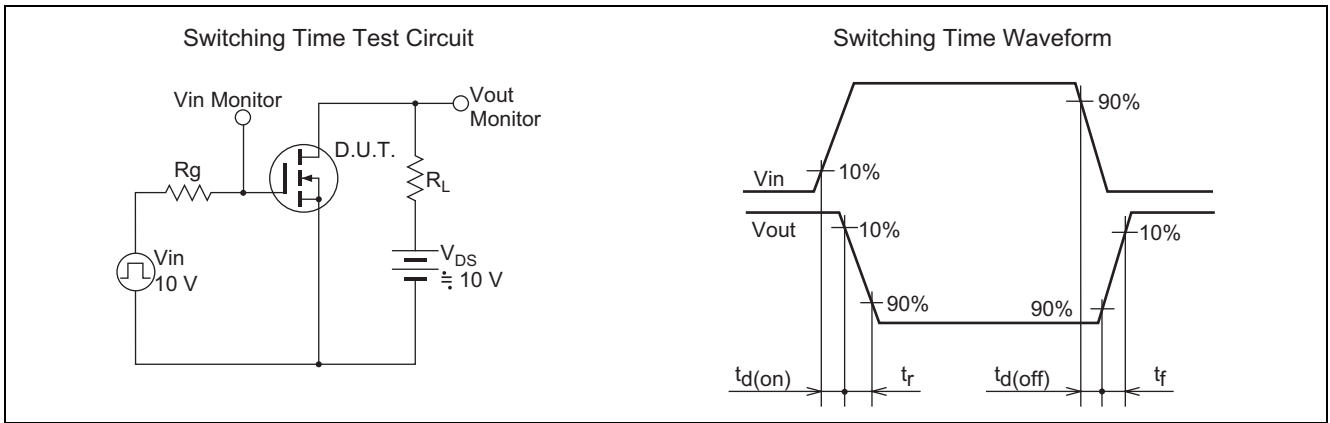
Avalanche Test Circuit



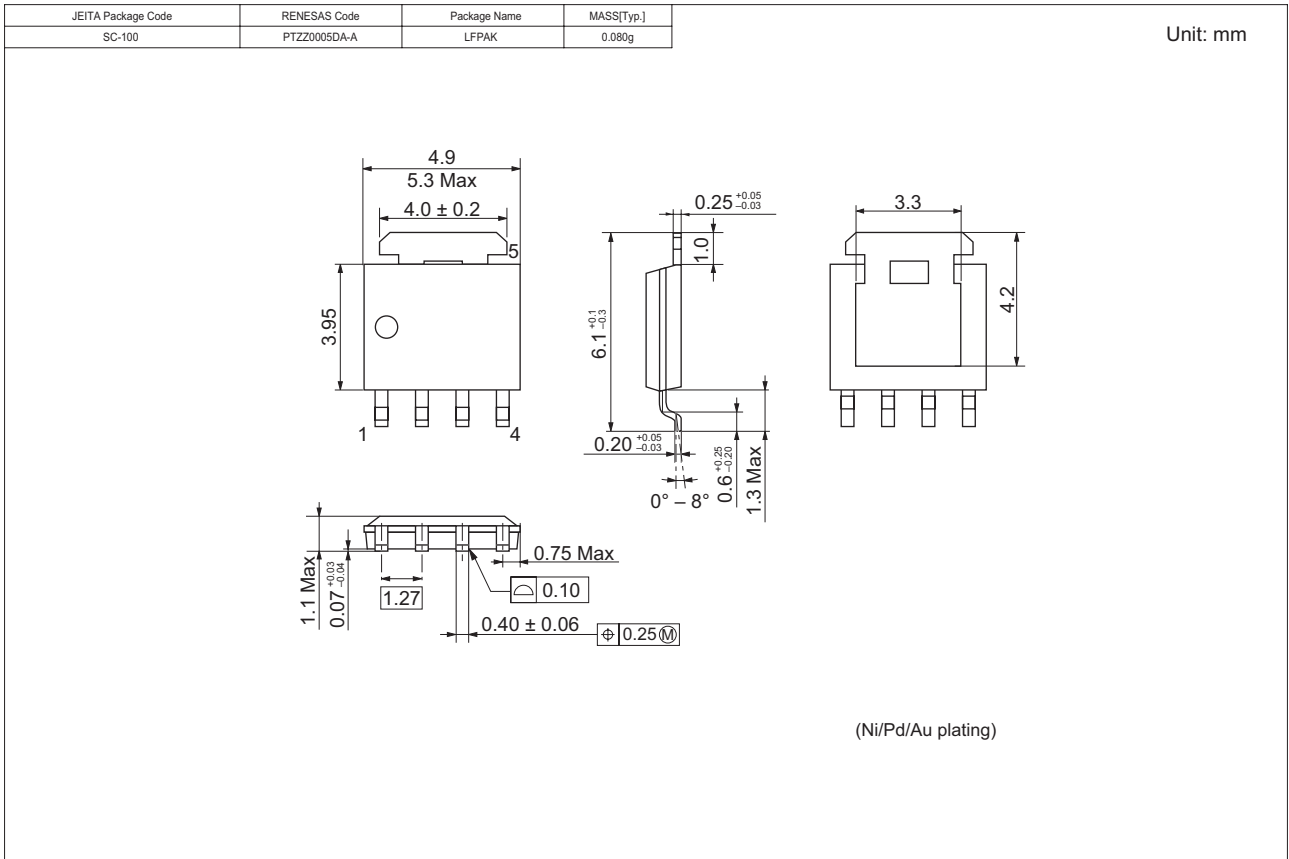
Avalanche Waveform
