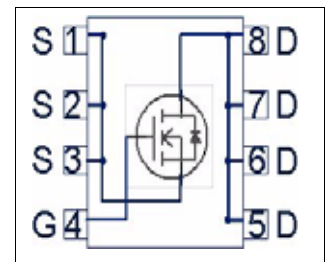

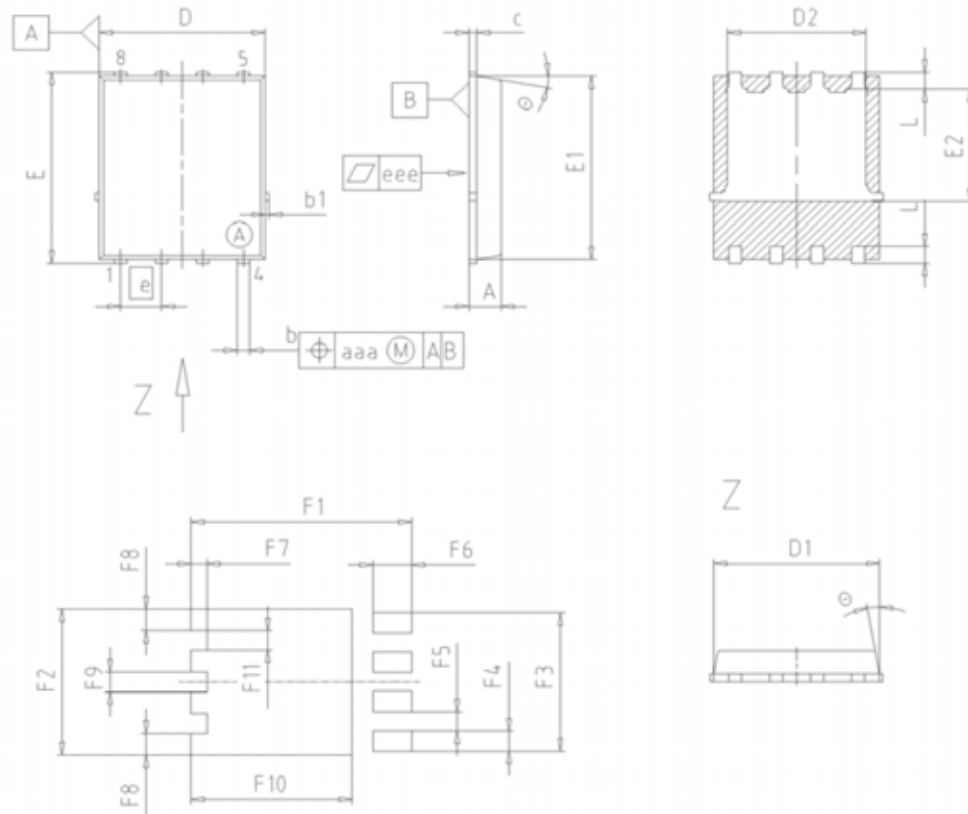

Figure 1 Outlines PG-TDSON-8, dimensions in mm/inches

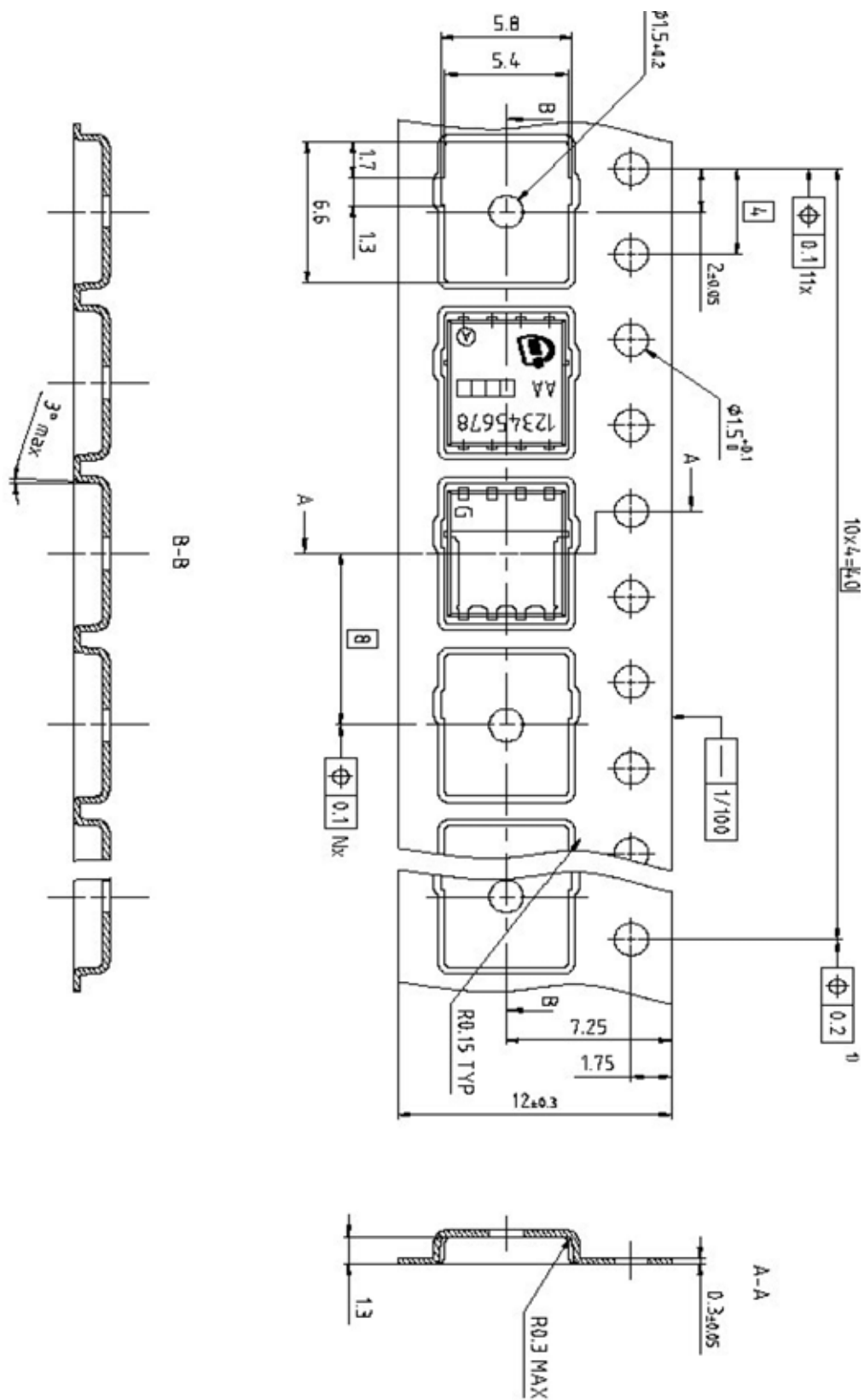


Figure 2 Outlines PG-TDSON-8 tape, dimension in mm/inches
