

















FORWARD TRANSFER ADMITTANCE vs. DRAIN CURRENT




DRAIN TO SOURCE ON-STATE RESISTANCE vs. DRAIN CURRENT






DRAIN TO SOURCE ON-STATE RESISTANCE vs. CHANNEL TEMPERATURE




