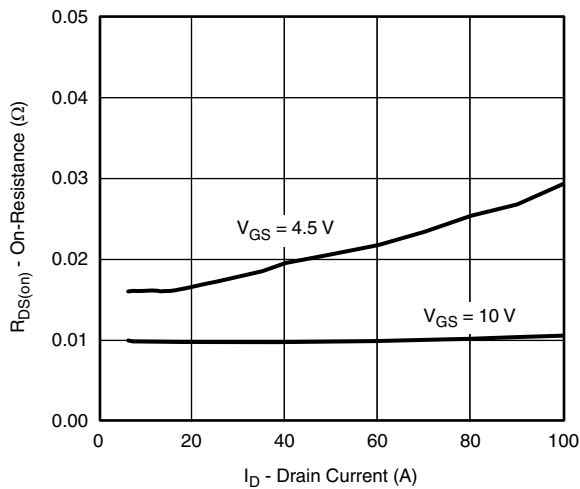

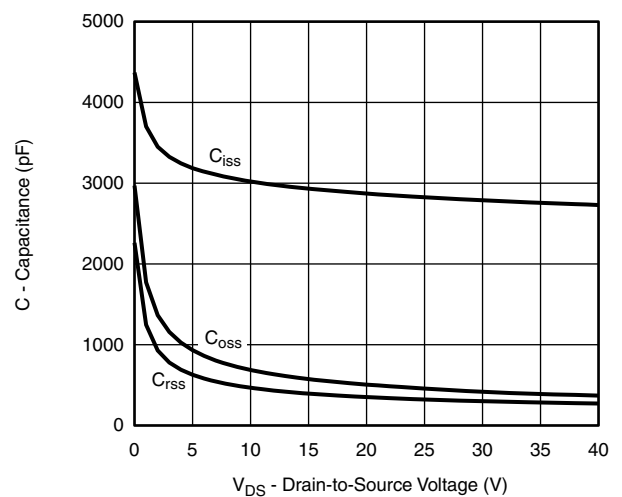

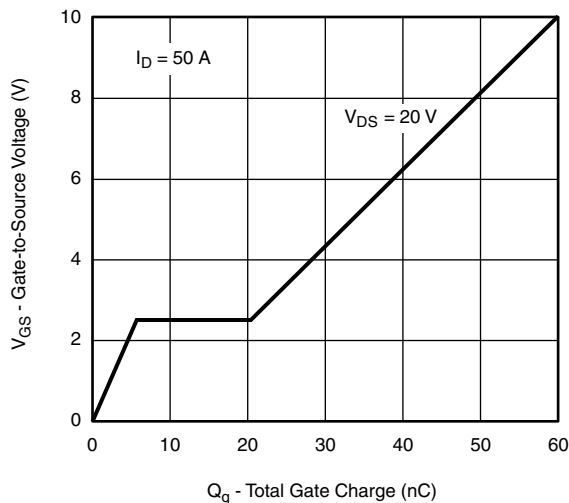

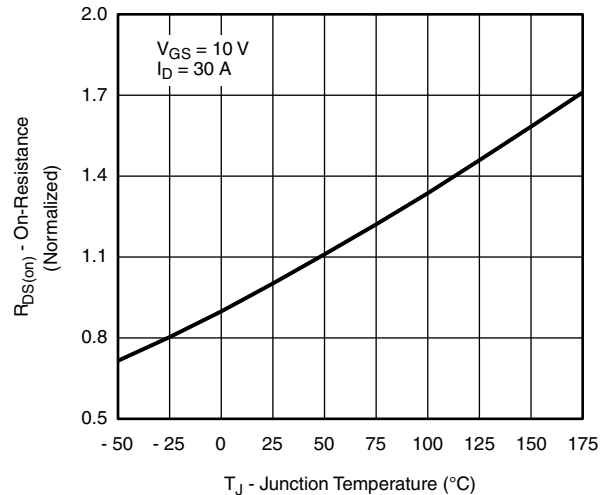
**On-Resistance vs. Drain Current**

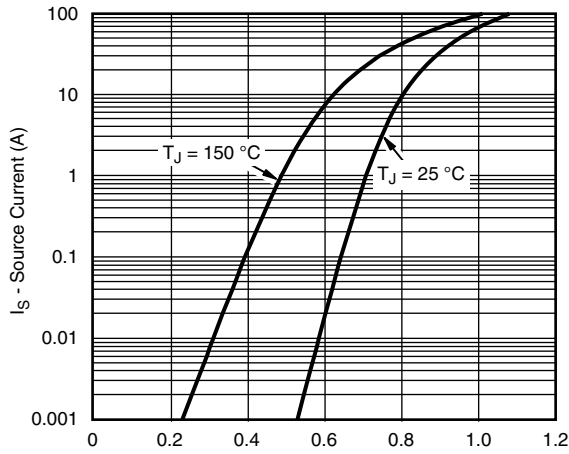

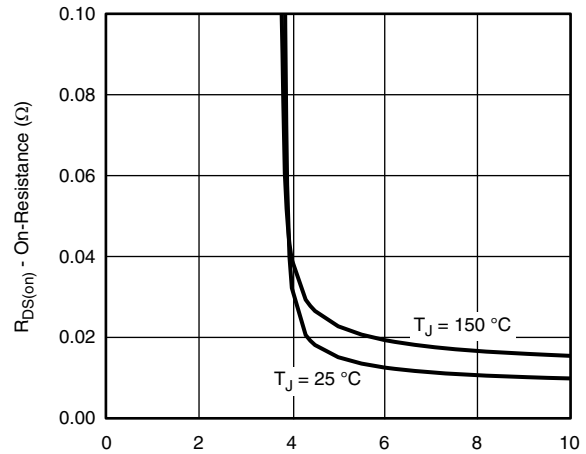
**On-Resistance vs. Junction Temperature**



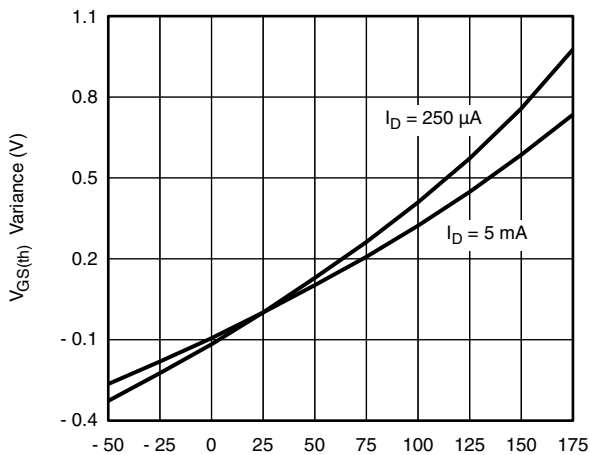

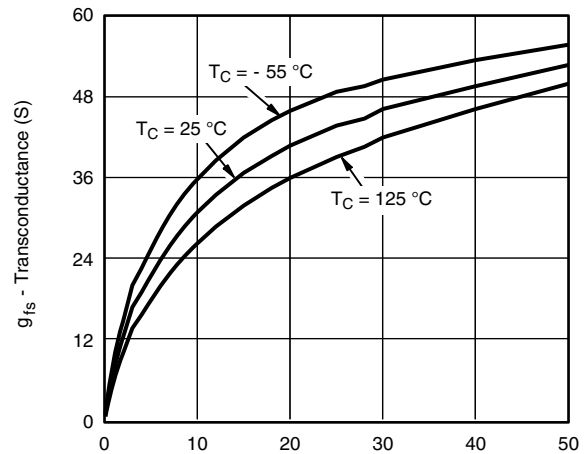
Source Drain Diode Forward Voltage



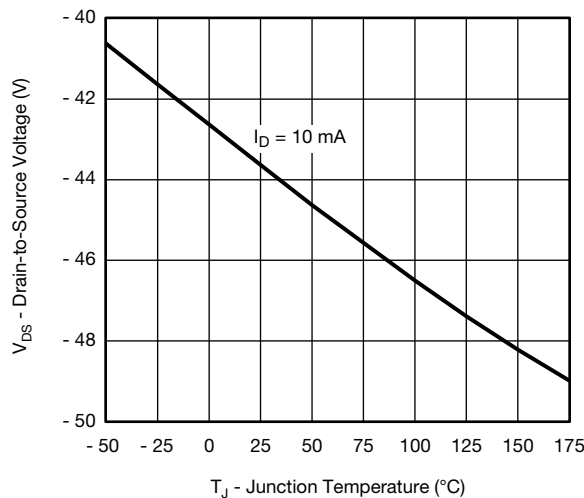
On-Resistance vs. Gate-to Source Voltage

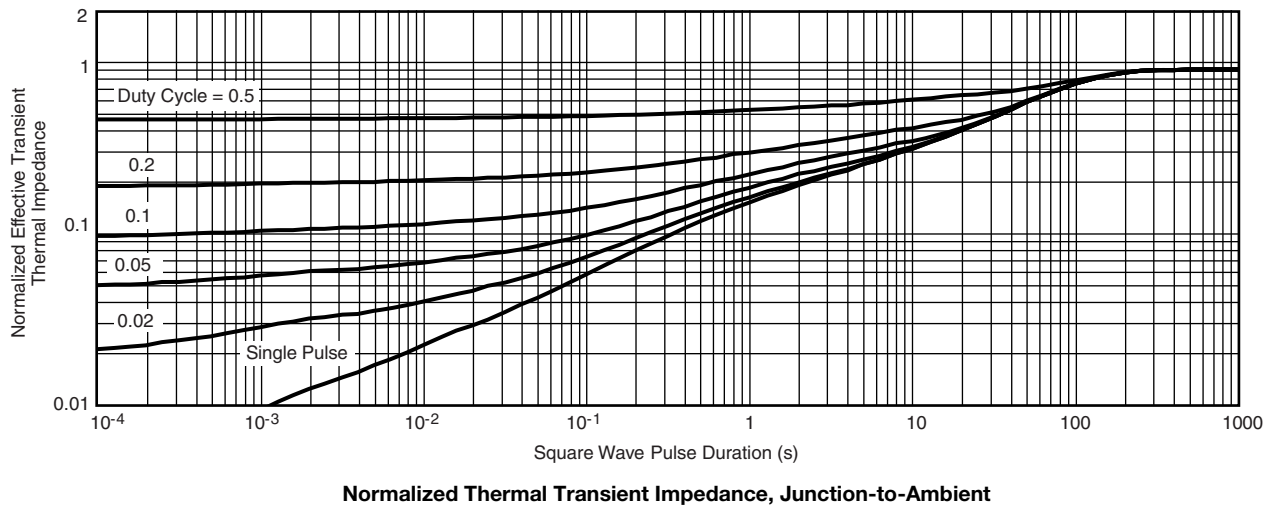
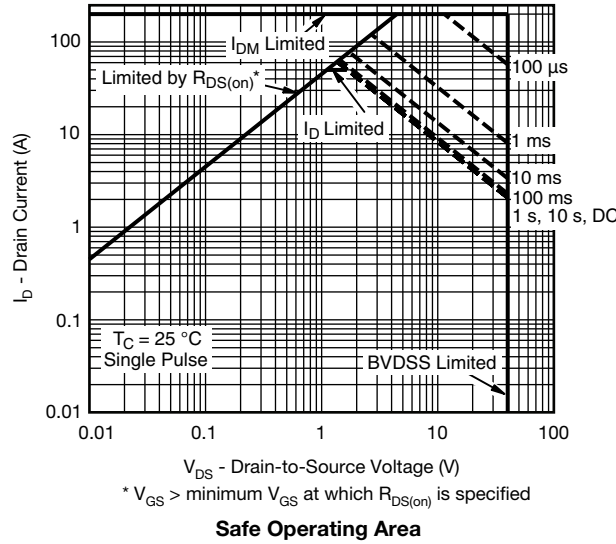

Drain Source Breakdown vs. Junction Temperature

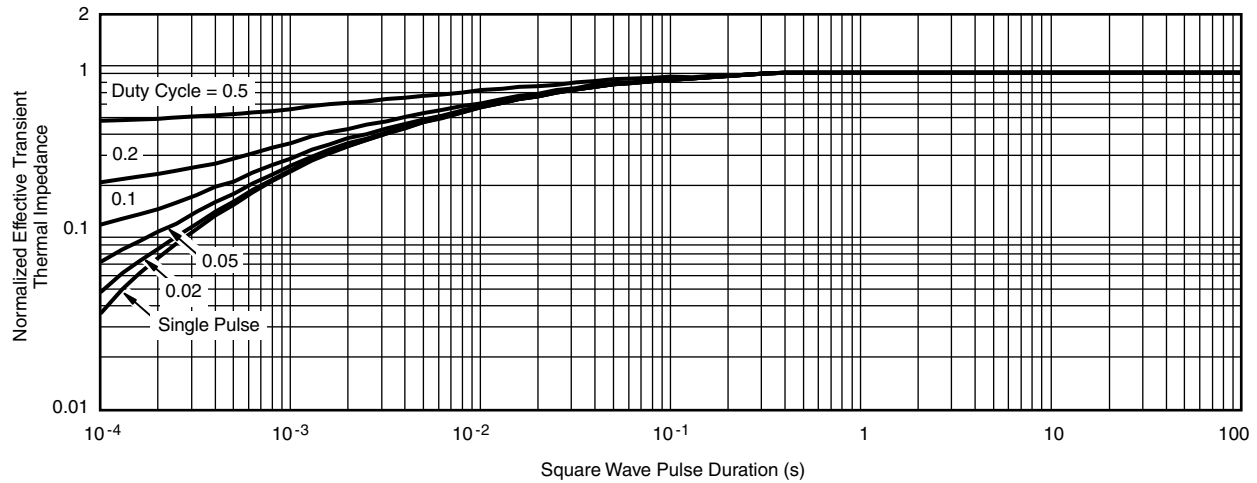
