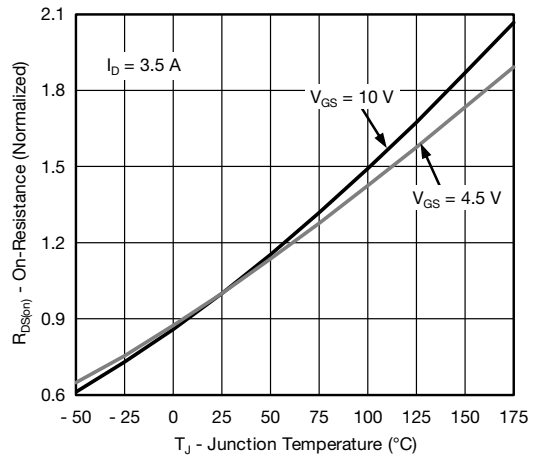

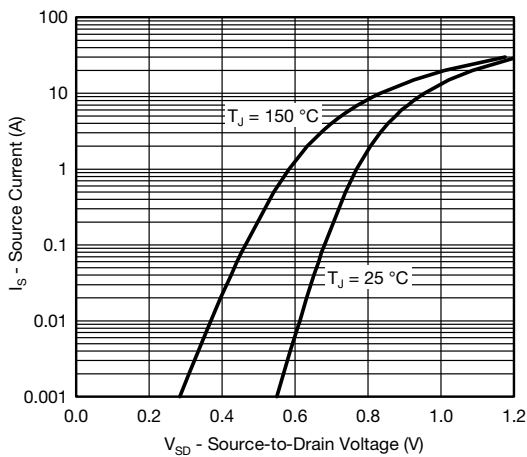

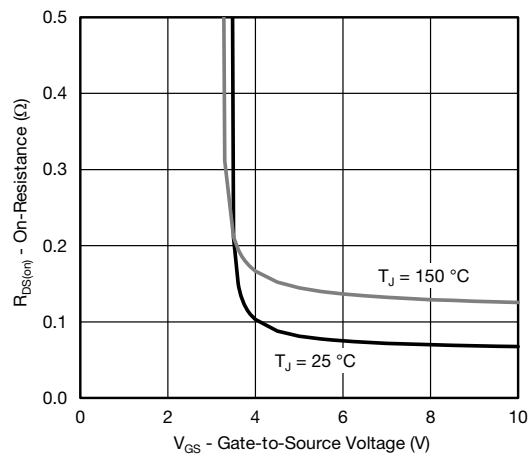
Gate Charge



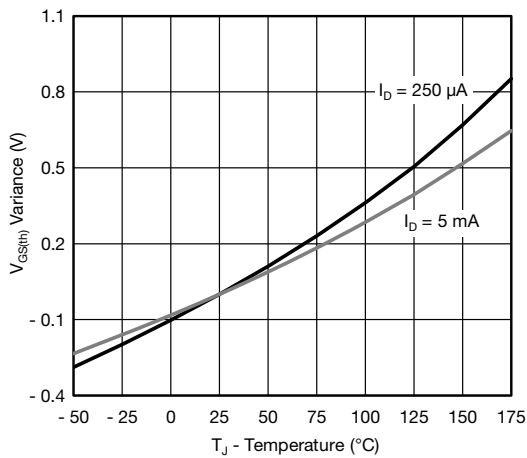
On-Resistance vs. Junction Temperature



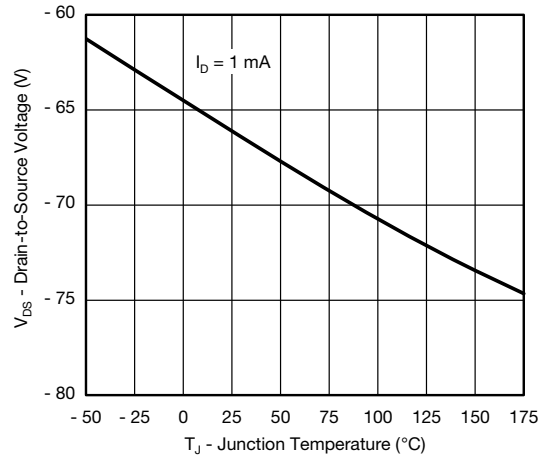
Source Drain Diode Forward Voltage



On-Resistance vs. Gate-to-Source Voltage

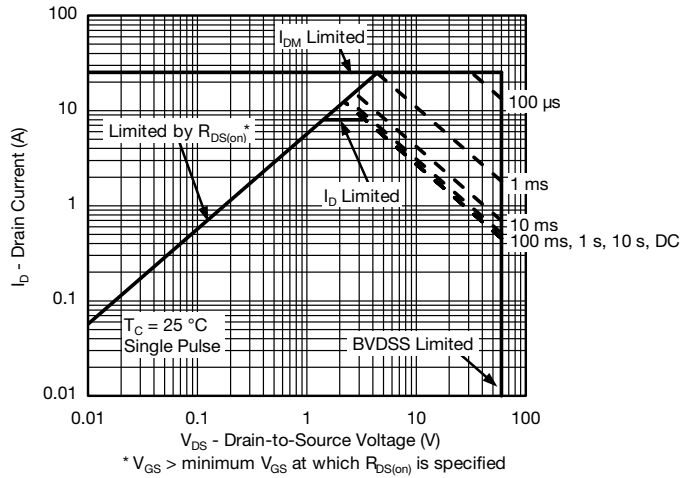

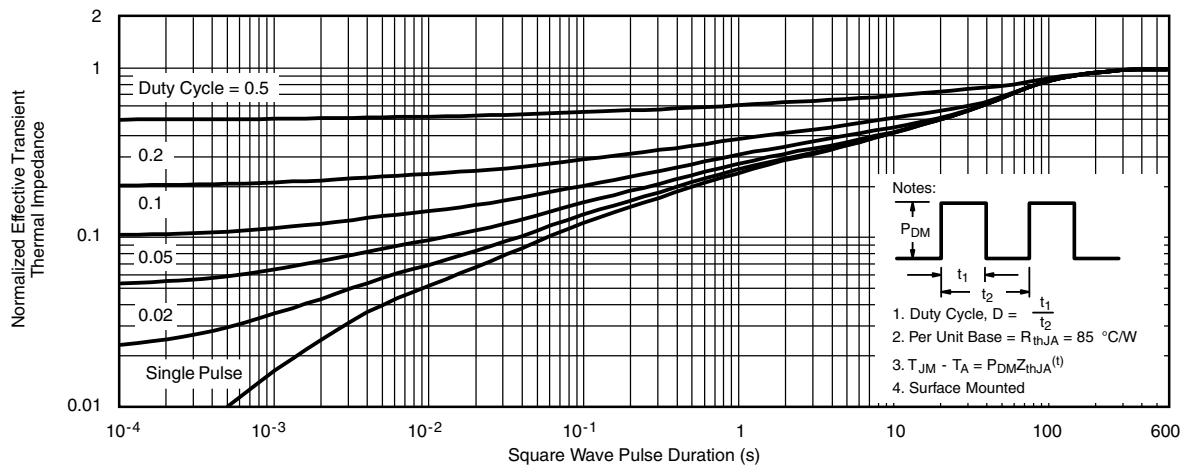


Drain Source Breakdown vs. Junction Temperature

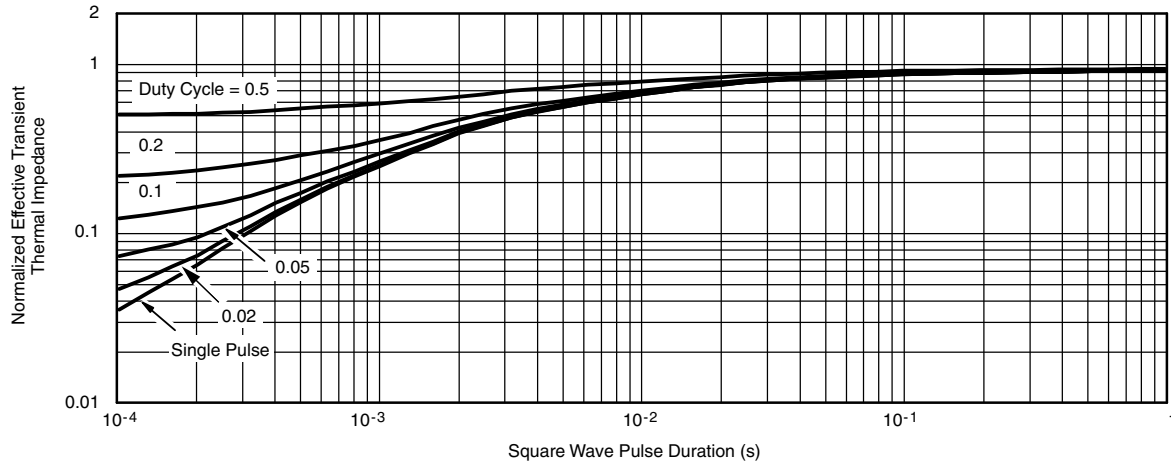

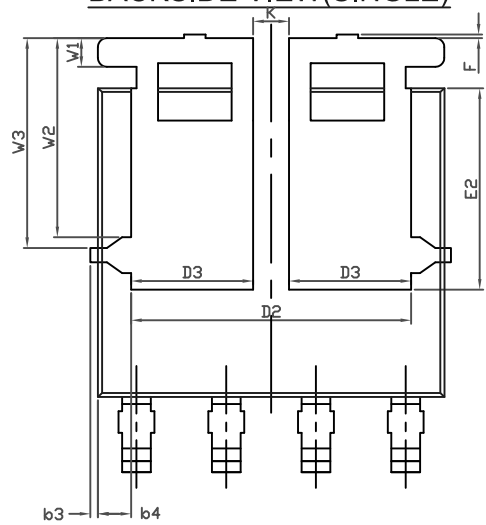
PowerPAK[®] SO-8L Case Outline



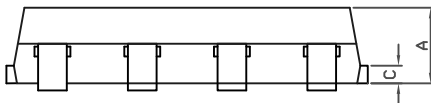
TOPSIDE VIEW
