





Fig.1 Ground Emitter Propagation Characteristics




Fig.2 Typical Output Characteristics 5.0mA 4.0mA 3.0mA 0.50 0.45 2.0mA 0.40 0.35

Fig.3 DC Current Gain vs. Collector Current(I)







Fig.4 DC current gain vs. output current (II)






Fig.10 Safe Operating Area
