




Fig.1 On-Region Characteristics




Fig.2 Transfer Characteristics




Fig.3 On-Resistance vs. Drain Current






Fig.4 On-Resistance vs. Junction temperature




Fig.7 Gate-Charge Characteristics





Fig.8 Threshold Voltage Variation with Temperature


